maps Boricua feminisms of the past, the present, and the future, defining what it means to be a “bad subject” of US empire. Engaging in radical collectivity, Pabón-Colón joins forces with Puerto Rican scholars, memoirists, artists, and activists—including feminist legends like Aurora Levins Morales and political trailblazers like Rosa Clemente—to ground this anthology in a tradition of resistance to empire at home. Through essays, roundtables, historiographies, poems, and other cross-genre writing, *Porque Estamos Aquí* asserts that Puerto Rican feminists are undeniably, irreducibly here and will guide generations of our shared movement for years to come.
