TYPES OF INTERNSHIPS AVAILABLE

PIIE TYPICALLY OFFERS INTERNSHIPS ACROSS VARIOUS DEPARTMENTS, INCLUDING:

- ECONOMIC RESEARCH AND ANALYSIS
- TRADE POLICY AND INTERNATIONAL FINANCE

CANDIDATES WITH STRONG QUANTITATIVE SKILLS, AN INTEREST IN ECONOMIC POLICY, AND A DESIRE TO WORK IN A FAST-PACED RESEARCH ENVIRONMENT TEND TO STAND OUT.

APPLICATION PROCESS AND REQUIREMENTS

APPLYING TO THE PETERSON INSTITUTE FOR INTERNATIONAL ECONOMICS INTERNSHIP REQUIRES CAREFUL PREPARATION AND ATTENTION TO DETAIL. THE COMPETITION CAN BE INTENSE, SO UNDERSTANDING THE PROCESS CAN GIVE YOU A SIGNIFICANT EDGE.

ESSENTIAL APPLICATION MATERIALS

APPLICANTS TYPICALLY NEED TO SUBMIT:

- A RESUME HIGHLIGHTING ACADEMIC ACHIEVEMENTS, RELEVANT COURSEWORK, AND ANY PRIOR RESEARCH OR INTERNSHIP EXPERIENCE.
- A COVER LETTER EXPRESSING YOUR INTEREST IN THE INSTITUTE AND HOW THE INTERNSHIP ALIGNS WITH YOUR CAREER GOALS.
- TRANSCRIPTS (OFFICIAL OR UNOFFICIAL) DEMONSTRATING STRONG ACADEMIC PERFORMANCE.
- LETTERS OF RECOMMENDATION MAY BE REQUESTED, ESPECIALLY FOR GRADUATE APPLICANTS.

TIPS FOR WRITING AN EFFECTIVE COVER LETTER

WHEN CRAFTING YOUR COVER LETTER, BE AUTHENTIC AND SPECIFIC. MENTION PARTICULAR RESEARCH AREAS AT PIIE THAT EXCITE YOU, SUCH AS GLOBAL TRADE DYNAMICS OR FISCAL POLICY. HIGHLIGHT HOW YOUR SKILLS AND EXPERIENCES MAKE YOU A GOOD FIT FOR THE ROLE. DEMONSTRATING FAMILIARITY WITH PIIE'S WORK SIGNALS GENUINE INTEREST.

DEADLINES AND TIMING

INTERNSHIP POSTINGS TYPICALLY APPEAR SEVERAL MONTHS BEFORE THE START DATE. IT'S A GOOD IDEA TO CHECK THE OFFICIAL PIIE WEBSITE OR SIGN UP FOR THEIR MAILING LIST TO STAY INFORMED. EARLY APPLICATIONS CAN SOMETIMES BENEFIT FROM MORE THOROUGH CONSIDERATION.

LEVERAGE YOUR INTERNSHIP EXPERIENCE

DOCUMENT THE PROJECTS YOU CONTRIBUTE TO AND THE SKILLS YOU DEVELOP. THESE WILL BE VALUABLE WHEN UPDATING

YOUR RESUME OR DISCUSSING YOUR EXPERIENCE IN FUTURE INTERVIEWS OR ACADEMIC APPLICATIONS.

2. **COVER LETTER:** A STATEMENT EXPRESSING INTEREST IN THE INTERNSHIP, FAMILIARITY WITH THE INSTITUTE'S WORK, AND CAREER ASPIRATIONS.
3. **ACADEMIC TRANSCRIPTS:** TO VERIFY COURSEWORK AND ACADEMIC STANDING.
4. **LETTERS OF RECOMMENDATION:** USUALLY FROM PROFESSORS OR EMPLOYERS WHO CAN ATTEST TO THE CANDIDATE'S ANALYTICAL CAPABILITIES.
5. **WRITING SAMPLES:** ESSAYS OR RESEARCH PAPERS DEMONSTRATING THE APPLICANT'S ABILITY TO ANALYZE ECONOMIC ISSUES.

ELIGIBILITY AND SELECTION CRITERIA

WHILE THERE IS NO STRICT REQUIREMENT ON NATIONALITY, PROFICIENCY IN ENGLISH IS ESSENTIAL DUE TO THE NATURE OF THE RESEARCH AND COMMUNICATION INVOLVED. THE INSTITUTE FAVORS CANDIDATES WITH:
