SINCE EACH SECTION COSTS \$182, CANDIDATES CAN CHOOSE TO TAKE ONE, TWO, OR ALL THREE PARTS AT ONCE DEPENDING ON THEIR PREPARATION AND SCHEDULE.

ADDITIONAL COSTS BEYOND THE EXAM FEE

CURRENT EXAM PRICING

AS OF THE LATEST INFORMATION, THE FEE FOR EACH PART OF THE SPECIAL ENROLLMENT EXAMINATION IS APPROXIMATELY \$182. IRS ANNUAL FILING SEASON PROGRAM (AFSP)

THE AFSP OFFERS A LOWER-COST ALTERNATIVE WITH FEES COMMONLY UNDER \$200. HOWEVER, IT DOES NOT CONFER THE UNLIMITED PRACTICE RIGHTS GRANTED TO EAs, MAKING THE ENROLLED AGENT EXAM A SUPERIOR OPTION FOR THOSE SEEKING FULL REPRESENTATION PRIVILEGES.

FACTORS INFLUENCING THE COST OF THE ENROLLED AGENT EXAM

SEVERAL VARIABLES CAN AFFECT HOW MUCH A CANDIDATE ULTIMATELY SPENDS ON THE EA EXAM PROCESS:

- **RETAKES:** CANDIDATES WHO DO NOT PASS A PART ON THE FIRST ATTEMPT MUST PAY THE \$182 FEE AGAIN FOR EACH RETAKE.
