UNDERSTANDING MARYLAND EMPLOYER WITHHOLDING REQUIREMENTS

EMPLOYERS IN MARYLAND ARE RESPONSIBLE FOR WITHHOLDING STATE INCOME TAXES FROM THEIR EMPLOYEES' WAGES AND REMITTING THOSE AMOUNTS TO THE MARYLAND COMPTROLLER'S OFFICE. THIS WITHHOLDING ACTS AS A PREPAYMENT OF THE EMPLOYEE'S STATE INCOME TAX LIABILITY, HELPING BOTH EMPLOYEES AND THE STATE MANAGE TAX COLLECTION THROUGHOUT THE YEAR.

WHO MUST WITHHOLD MARYLAND STATE INCOME TAX?

ANY EMPLOYER WHO HAS EMPLOYEES WORKING IN MARYLAND OR WHO ARE RESIDENTS OF MARYLAND MUST WITHHOLD STATE INCOME TAX. THIS INCLUDES:

- BUSINESSES OF ALL SIZES OPERATING IN MARYLAND
- OUT-OF-STATE EMPLOYERS WITH EMPLOYEES PERFORMING SERVICES IN MARYLAND
- NON-PROFIT ORGANIZATIONS WITH EMPLOYEES SUBJECT TO MARYLAND TAX

EVEN IF YOUR BUSINESS IS SMALL OR YOU EMPLOY PART-TIME WORKERS, WITHHOLDING REQUIREMENTS STILL APPLY. FAILURE TO WITHHOLD CORRECTLY CAN LEAD TO PENALTIES, INTEREST, AND AUDITS BY THE MARYLAND COMPTROLLER'S OFFICE.

REGISTERING FOR A MARYLAND WITHHOLDING ACCOUNT

BEFORE WITHHOLDING ANY TAXES, EMPLOYERS MUST REGISTER FOR A MARYLAND WITHHOLDING TAX ACCOUNT NUMBER. YOU CAN REGISTER ONLINE THROUGH THE COMPTROLLER OF MARYLAND'S WEBSITE OR BY SUBMITTING THE APPROPRIATE FORMS BY MAIL. THIS NUMBER IS ESSENTIAL FOR FILING WITHHOLDING RETURNS AND MAKING PAYMENTS.

MARYLAND STATE INCOME TAX WITHHOLDING RATES AND TABLES FOR 2023

MARYLAND'S INCOME TAX WITHHOLDING RATES ARE PROGRESSIVE, MEANING THEY VARY DEPENDING ON THE EMPLOYEE'S TAXABLE INCOME. FOR EMPLOYERS, THIS MEANS USING THE CORRECT TAX TABLES OR FORMULAS TO DETERMINE THE AMOUNT TO WITHHOLD PER PAYCHECK.

HOW TO CALCULATE MARYLAND WITHHOLDING

MARYLAND PROVIDES EMPLOYERS WITH WITHHOLDING TABLES THAT CORRESPOND TO VARIOUS PAY FREQUENCIES—WEEKLY, BIWEEKLY, SEMIMONTHLY, AND MONTHLY. THESE TABLES CONSIDER:

- THE EMPLOYEE'S FILING STATUS (SINGLE, MARRIED, ETC.)
- ALLOWANCES CLAIMED ON THE EMPLOYEE'S WITHHOLDING ALLOWANCE CERTIFICATE (FORM MW507)
- ADDITIONAL WITHHOLDING AMOUNTS SPECIFIED BY THE EMPLOYEE

EMPLOYERS SHOULD USE THE LATEST 2023 WITHHOLDING TABLES PUBLISHED BY THE COMPTROLLER'S OFFICE TO ENSURE ACCURACY. USING OUTDATED TABLES CAN CAUSE UNDERWITHHOLDING OR OVERWITHHOLDING, BOTH OF WHICH CAN CREATE COMPLICATIONS FOR EMPLOYEES AND EMPLOYERS ALIKE.

MARYLAND LOCAL INCOME TAX RATES

IN ADDITION TO THE STATE INCOME TAX, MARYLAND COUNTIES AND BALTIMORE CITY IMPOSE LOCAL INCOME TAXES, WHICH EMPLOYERS MUST ALSO WITHHOLD. THE COMBINED STATE AND LOCAL TAX RATES VARY DEPENDING ON THE EMPLOYEE'S RESIDENCE. FOR EXAMPLE, MONTGOMERY COUNTY HAS A DIFFERENT LOCAL TAX RATE THAN BALTIMORE COUNTY.

EMPLOYERS SHOULD KEEP AN UPDATED LIST OF LOCAL TAX RATES, AS THESE RATES CAN CHANGE ANNUALLY. THE MARYLAND COMPTROLLER'S WEBSITE PUBLISHES CURRENT LOCAL TAX RATES, WHICH MUST BE APPLIED WHEN CALCULATING TOTAL WITHHOLDING AMOUNTS.

FILING AND PAYMENT DEADLINES FOR MARYLAND EMPLOYER WITHHOLDING

TIMELY FILING AND PAYMENT OF WITHHELD TAXES ARE CRITICAL PARTS OF MARYLAND TAX COMPLIANCE. THE STATE REQUIRES EMPLOYERS TO ADHERE TO SPECIFIC SCHEDULES BASED ON THE AMOUNT OF TAX WITHHELD.

WITHHOLDING DEPOSIT SCHEDULES

MARYLAND CATEGORIZES EMPLOYERS INTO DIFFERENT DEPOSIT SCHEDULES:

- **MONTHLY DEPOSITORS:** EMPLOYERS WHO WITHHOLD LESS THAN \$100,000 ANNUALLY USUALLY DEPOSIT WITHHOLDING TAXES MONTHLY. PAYMENTS ARE DUE BY THE 15TH DAY OF THE FOLLOWING MONTH.
- **QUARTERLY DEPOSITORS:** EMPLOYERS WITHHOLDING LESS THAN \$600 ANNUALLY MAY DEPOSIT QUARTERLY, WITH PAYMENTS DUE BY THE LAST DAY OF THE MONTH FOLLOWING THE QUARTER.
- **ACCELERATED DEPOSITORS:** EMPLOYERS WITH HIGHER WITHHOLDING AMOUNTS MAY BE REQUIRED TO DEPOSIT ON A SEMIWEEKLY BASIS.

UNDERSTANDING YOUR DEPOSIT SCHEDULE IS VITAL TO AVOID LATE PAYMENT PENALTIES AND INTEREST.

WITHHOLDING TAX RETURNS

EMPLOYERS MUST FILE WITHHOLDING TAX RETURNS WITH THE MARYLAND COMPTROLLER'S OFFICE, DETAILING THE WAGES PAID AND AMOUNTS WITHHELD. THE FREQUENCY OF FILING MATCHES THE DEPOSIT SCHEDULE AND CAN BE DONE ELECTRONICALLY OR VIA PAPER FORMS.

EMPLOYERS MUST ALSO PROVIDE EMPLOYEES WITH FORM W-2 BY JANUARY 31ST FOLLOWING THE TAX YEAR, SHOWING THE TOTAL WAGES PAID AND TAXES WITHHELD, INCLUDING MARYLAND STATE AND LOCAL TAXES.

BEST PRACTICES FOR MARYLAND EMPLOYERS REGARDING WITHHOLDING

NAVIGATING WITHHOLDING TAXES CAN BE CHALLENGING, BUT ADOPTING GOOD PRACTICES CAN SIMPLIFY THE PROCESS AND MINIMIZE ERRORS.

MAINTAIN ACCURATE EMPLOYEE INFORMATION

COLLECT UP-TO-DATE WITHHOLDING ALLOWANCE CERTIFICATES (FORM MW507) FROM EMPLOYEES. ENCOURAGE EMPLOYEES TO UPDATE THEIR FORMS WHENEVER THEIR TAX SITUATION CHANGES, SUCH AS MARRIAGE, DIVORCE, OR THE BIRTH OF A CHILD. ACCURATE INFORMATION ENSURES PROPER WITHHOLDING AMOUNTS.

USE RELIABLE PAYROLL SOFTWARE

- NOT PROVIDING EMPLOYEES WITH TIMELY W-2 FORMS

EMPLOYERS ARE ENCOURAGED TO USE THE LATEST WITHHOLDING TABLES PUBLISHED BY THE MARYLAND COMPTROLLER TO ENSURE ACCURACY. FOR EXAMPLE, AN EMPLOYEE EARNING \$50,000 ANNUALLY IN MONTGOMERY COUNTY FACES A COMBINED WITHHOLDING RATE THAT INCLUDES THE STATE RATE PLUS THE COUNTY TAX, WHICH CAN REACH APPROXIMATELY 3.2% IN LOCAL TAX. THIS LAYERED TAX STRUCTURE COMPLICATES PAYROLL CALCULATIONS, PARTICULARLY FOR BUSINESSES WITH EMPLOYEES IN MULTIPLE COUNTIES.

REGISTRATION AND REPORTING OBLIGATIONS

BEFORE WITHHOLDING TAXES, MARYLAND EMPLOYERS MUST REGISTER WITH THE STATE'S COMPTROLLER TO OBTAIN AN EMPLOYER IDENTIFICATION NUMBER (EIN) SPECIFIC TO MARYLAND. THE WITHHOLDING GUIDE 2023 STRESSES THE NECESSITY OF TIMELY REGISTRATION, ESPECIALLY FOR NEW BUSINESSES AND OUT-OF-STATE EMPLOYERS WITH MARYLAND EMPLOYEES.

ONCE REGISTERED, EMPLOYERS MUST ADHERE TO STRICT REPORTING SCHEDULES. MARYLAND REQUIRES MONTHLY OR QUARTERLY WITHHOLDING TAX FILINGS DEPENDING ON THE AMOUNT WITHHELD. EMPLOYERS WHO WITHHOLD MORE THAN \$500 MONTHLY MUST FILE MONTHLY RETURNS, WHILE THOSE BELOW THAT THRESHOLD MAY OPT FOR QUARTERLY FILINGS. THE GUIDE UNDERSCORES THAT FILING FREQUENCY IMPACTS CASH FLOW AND ADMINISTRATIVE BURDEN, MAKING IT A STRATEGIC CONSIDERATION.

ELECTRONIC FILING AND PAYMENT SYSTEMS
