On the other hand, Chang cautions that systemic inefficiencies and intellectual property concerns could limit China's innovation capacity.

Moreover, the CCP's control over information and suppression of academic freedom may stifle creativity and entrepreneurship. The potential technological lag relative to Western competitors could exacerbate China's economic challenges, reinforcing Chang's thesis of impending collapse.
