BORROWING FROM SYMBOLIC INTERACTIONISM AND LATER ECHOED BY THEORISTS LIKE JUDITH BUTLER, LORBER EMPHASIZES THAT GENDER IS PERFORMED THROUGH DAILY ACTIONS. EVERY INTERACTION, FROM HOW WE DRESS TO HOW WE SPEAK, CONTRIBUTES TO THE MAINTENANCE OF GENDER CATEGORIES. GENDER AS A SYSTEM OF STRATIFICATION

SMALL ACTIONS, LIKE QUESTIONING WHY CERTAIN TOYS ARE LABELED "FOR BOYS" OR "FOR GIRLS" OR WHY CERTAIN BEHAVIORS ARE GENDERED, CAN DISRUPT THE SOCIAL CONSTRUCTION OF GENDER. ENCOURAGING CHILDREN AND ADULTS TO EXPLORE INTERESTS AND ROLES BEYOND TRADITIONAL GENDER LINES PROMOTES GREATER FREEDOM.

ADVOCATE FOR INSTITUTIONAL CHANGE

ORGANIZATIONS CAN REVIEW POLICIES THAT INADVERTENTLY UPHOLD GENDER NORMS. THIS MIGHT INCLUDE IMPLEMENTING GENDER-NEUTRAL RESTROOMS, OFFERING GENDER SENSITIVITY TRAINING, OR ENSURING EQUITABLE HIRING AND PROMOTION PRACTICES.

SUPPORT GENDER DIVERSITY AND EXPRESSION

GENDER AS A SOCIAL INSTITUTION

IMPLICATIONS OF THE SOCIAL CONSTRUCTIONIST VIEW ON GENDER

LORBER'S APPROACH, HOWEVER, REMAINS DISTINCTIVE FOR ITS INSTITUTIONAL ANALYSIS. SHE METICULOUSLY CHARTS HOW GENDER IS INSTITUTIONALIZED ACROSS VARIOUS SOCIAL DOMAINS, OFFERING A MACRO-LEVEL UNDERSTANDING THAT COMPLEMENTS BUTLER'S MICRO-LEVEL FOCUS ON IDENTITY PERFORMANCE.

APPLICATIONS OF LORBER'S THEORY IN CONTEMPORARY SOCIETY

RECOGNIZING GENDER AS SOCIALLY CONSTRUCTED ALLOWS EDUCATORS TO DEVELOP MORE INCLUSIVE PEDAGOGIES THAT CHALLENGE THESE BIASES.

GENDER IN THE WORKPLACE

LORBER'S FRAMEWORK ALSO SHEDS LIGHT ON WORKPLACE INEQUALITIES. GENDERED DIVISION OF LABOR, WAGE GAPS, AND GLASS CEILING EFFECTS ARE UNDERSTOOD AS MANIFESTATIONS OF INSTITUTIONALIZED GENDER NORMS RATHER THAN NATURAL OUTCOMES. BY ANALYZING ORGANIZATIONAL CULTURES AND POLICIES THROUGH A SOCIAL CONSTRUCTIONIST LENS, COMPANIES CAN IDENTIFY SYSTEMIC BARRIERS AND PROMOTE EQUITY.

HEALTHCARE AND GENDER

HEALTHCARE PRACTICES OFTEN REFLECT GENDERED ASSUMPTIONS ABOUT BODIES AND HEALTH NEEDS. LORBER'S THEORY ENCOURAGES A CRITICAL ASSESSMENT OF HOW MEDICAL RESEARCH, DIAGNOSIS, AND TREATMENT MIGHT PERPETUATE GENDER BIASES. FOR INSTANCE, THE UNDERREPRESENTATION OF WOMEN IN CLINICAL TRIALS AND GENDERED INTERPRETATIONS OF SYMPTOMS HAVE IMPLICATIONS FOR PATIENT CARE.

CRITIQUES AND LIMITATIONS OF LORBER'S SOCIAL CONSTRUCTION OF GENDER

DESPITE ITS PROFOUND INFLUENCE, JUDITH LORBER'S SOCIAL CONSTRUCTIONIST APPROACH IS NOT WITHOUT CRITICISM. SOME SCHOLARS ARGUE THAT FOCUSING PREDOMINANTLY ON SOCIAL FACTORS CAN UNDERPLAY THE ROLE OF BIOLOGY IN SHAPING GENDER DIFFERENCES. WHILE LORBER ACKNOWLEDGES THAT BIOLOGY EXISTS, SHE EMPHASIZES THAT ITS SOCIAL INTERPRETATION IS KEY, WHICH SOME CRITICS SEE AS AN OVERCORRECTION.

ANOTHER CRITIQUE CONCERNS THE APPLICABILITY OF LORBER'S FRAMEWORK ACROSS DIVERSE CULTURES. GENDER CONSTRUCTION VARIES SIGNIFICANTLY ACROSS SOCIETIES, AND SOME ARGUE THAT LORBER'S ANALYSIS, PRIMARILY BASED ON WESTERN CONTEXTS, MAY NOT FULLY CAPTURE THIS DIVERSITY. ADDITIONALLY, INTERSECTIONAL CRITIQUES HIGHLIGHT THAT GENDER CANNOT BE FULLY UNDERSTOOD WITHOUT CONSIDERING RACE, CLASS, SEXUALITY, AND OTHER AXES OF IDENTITY, AREAS WHERE LORBER'S EARLIER WORK WAS LESS EXPLICIT.
