TO STAY AT THE FOREFRONT OF CORRECTIONAL OFFICER TRAINING, CORECIVIC COULD CONSIDER EXPANDING ITS FOCUS ON:

- **MENTAL HEALTH AWARENESS:** DEEPENING TRAINING ON RECOGNIZING AND MANAGING MENTAL HEALTH CRISES WITHIN THE INMATE POPULATION.
- **CULTURAL COMPETENCY:** ENHANCING MODULES THAT PREPARE OFFICERS FOR DIVERSE POPULATIONS, REDUCING BIAS AND IMPROVING COMMUNICATION.
- **ADVANCED CRISIS INTERVENTION:** INCORPORATING MORE SOPHISTICATED DE-ESCALATION TECHNIQUES AND CONFLICT RESOLUTION STRATEGIES.
- **FEEDBACK AND ASSESSMENT:** IMPLEMENTING ROBUST POST-TRAINING EVALUATIONS TO MEASURE OUTCOMES AND IDENTIFY GAPS IN SKILLS OR KNOWLEDGE.

SUCH INITIATIVES WOULD NOT ONLY IMPROVE OFFICER PERFORMANCE BUT ALSO CONTRIBUTE TO SAFER AND MORE HUMANE CORRECTIONAL ENVIRONMENTS.
