LORRAINE'S GIFTS INCLUDED SEEING SPIRITS AND READING AURAS, WHICH SHE BELIEVED HELPED THEM IDENTIFY AND UNDERSTAND THE ENTITIES THEY ENCOUNTERED. THEIR COMPLEMENTARY SKILLS MADE THEM A UNIQUE DUO IN THE FIELD OF PARANORMAL INVESTIGATION.

FAMOUS ED AND LORRAINE WARREN CASE FILES

OVER THE YEARS, THE WARRENS INVESTIGATED OVER 10,000 CASES, BUT A HANDFUL STAND OUT DUE TO THEIR NOTORIETY AND THE CULTURAL IMPACT THEY HAVE HAD.

THE AMITYVILLE HORROR

PERHAPS THE MOST FAMOUS ED AND LORRAINE WARREN CASE IS THE AMITYVILLE HORROR HAUNTING. IN 1975, THE WARRENS WERE CALLED TO INVESTIGATE A HOUSE IN AMITYVILLE, NEW YORK, WHERE THE LUTZ FAMILY CLAIMED TO EXPERIENCE TERRIFYING SUPERNATURAL EVENTS SHORTLY AFTER MOVING IN. THIS CASE BECAME THE BASIS FOR ONE OF THE MOST SUCCESSFUL HORROR FRANCHISES EVER, SPARKING BOTH FASCINATION AND SKEPTICISM. THE AMITYVILLE CASE PERFECTLY ILLUSTRATES HOW THE WARRENS' INVESTIGATIONS BLENDED PERSONAL TESTIMONIES WITH PARANORMAL RESEARCH, MAKING IT A CORNERSTONE OF THEIR LEGACY.

THE PERRON FAMILY HAUNTING

THE ENFIELD POLTERGEIST

WHILE THE ENFIELD POLTERGEIST CASE IN ENGLAND WAS NOT DIRECTLY INVESTIGATED BY ED AND LORRAINE, THEY WERE CONSULTED FOR THEIR EXPERTISE.
