HOW TO CHECK OKLAHOMA VEHICLE TITLE HISTORY

IF YOU'RE CONSIDERING PURCHASING A USED CAR OR NEED TO VERIFY YOUR VEHICLE'S RECORDS, OKLAHOMA PROVIDES SEVERAL WAYS TO OBTAIN TITLE HISTORY INFORMATION.

OBTAINING A TITLE HISTORY REPORT

THE OKLAHOMA TAX COMMISSION OFFERS VEHICLE TITLE SERVICES THAT ALLOW YOU TO REQUEST A TITLE HISTORY REPORT. THIS REPORT INCLUDES ALL RECORDED OWNERSHIP CHANGES, LIENS, SALVAGE BRANDING, AND ODOMETER READINGS. YOU CAN REQUEST THIS REPORT ONLINE, BY MAIL, OR IN PERSON AT AN OKLAHOMA TAX COMMISSION OFFICE.

TO REQUEST A VEHICLE TITLE HISTORY REPORT, YOU GENERALLY NEED:

- VEHICLE IDENTIFICATION NUMBER (VIN)
- VEHICLE LICENSE PLATE NUMBER (IF APPLICABLE)

- PAYMENT FOR THE PROCESSING FEE

THIRD-PARTY VEHICLE HISTORY REPORTS

BESIDES THE OFFICIAL STATE RESOURCES, MANY THIRD-PARTY COMPANIES LIKE CARFAX, AUTOCHECK, AND OTHERS PROVIDE COMPREHENSIVE VEHICLE HISTORY REPORTS. THESE OFTEN INCLUDE ACCIDENT HISTORY, SERVICE RECORDS, AND TITLE STATUS ACROSS MULTIPLE STATES, WHICH CAN BE PARTICULARLY USEFUL FOR VEHICLES THAT HAVE TRAVELED ACROSS STATE LINES.

WHILE THESE REPORTS COME AT A COST, THEY CAN BE EXTREMELY VALUABLE FOR SPOTTING HIDDEN PROBLEMS THAT MIGHT NOT BE IMMEDIATELY APPARENT THROUGH A STANDARD TITLE SEARCH.

UNDERSTANDING DIFFERENT TITLE BRANDS IN OKLAHOMA

ONE OF THE MOST IMPORTANT ASPECTS OF OKLAHOMA VEHICLE TITLE HISTORY IS THE TITLE BRAND. TITLE BRANDS ARE LABELS PLACED ON A VEHICLE'S TITLE INDICATING ITS CONDITION OR PAST ISSUES. RECOGNIZING THESE BRANDS CAN HELP YOU MAKE INFORMED DECISIONS.

COMMON TITLE BRANDS IN OKLAHOMA

- **CLEAN TITLE:** NO SIGNIFICANT ISSUES; VEHICLE IS CONSIDERED ROADWORTHY.
- **SALVAGE TITLE:** VEHICLE HAS BEEN DAMAGED SEVERELY (USUALLY TOTALED BY INSURANCE) AND DECLARED A TOTAL LOSS.
- **REBUILT OR RECONSTRUCTED TITLE:** VEHICLE WAS PREVIOUSLY SALVAGED BUT HAS BEEN REPAIRED AND INSPECTED FOR ROADWORTHINESS.
- **FLOOD DAMAGE TITLE:** VEHICLE HAS WATER DAMAGE THAT MAY AFFECT ITS FUNCTIONALITY AND SAFETY.
- **LIEN TITLE:** THE VEHICLE HAS AN OUTSTANDING LIEN, MEANING A LENDER HAS A LEGAL INTEREST IN THE VEHICLE UNTIL THE LOAN IS PAID OFF.

HOW TITLE BRANDS AFFECT VEHICLE VALUE AND INSURANCE

VEHICLES WITH SALVAGE OR REBUILT TITLES TYPICALLY HAVE A LOWER MARKET VALUE AND CAN BE HARDER TO INSURE. INSURANCE PROVIDERS MAY LIMIT COVERAGE OR CHARGE HIGHER PREMIUMS DUE TO THE INCREASED RISK ASSOCIATED WITH THESE VEHICLES. IF YOU'RE BUYING A CAR WITH A BRANDED TITLE, IT'S WISE TO GET A THOROUGH MECHANICAL INSPECTION AND CONSULT YOUR INSURANCE AGENT BEFOREHAND.

TRANSFERRING OKLAHOMA VEHICLE TITLES: WHAT YOU SHOULD KNOW

WHETHER YOU'RE BUYING OR SELLING A VEHICLE IN OKLAHOMA, UNDERSTANDING HOW TO TRANSFER A VEHICLE TITLE PROPERLY IS KEY TO A SMOOTH TRANSACTION.

STEPS FOR TRANSFERRING A VEHICLE TITLE IN OKLAHOMA

1. **SELLER COMPLETES THE TITLE TRANSFER SECTION:** THIS INCLUDES SIGNING THE TITLE AND FILLING IN THE BUYER'S INFORMATION.

4. ****LIEN RELEASE:**** IF THERE WAS A LIEN ON THE VEHICLE, A LIEN RELEASE DOCUMENT IS NECESSARY.
5. ****SUBMIT DOCUMENTS TO OTC:**** THE BUYER OR SELLER SUBMITS THE PAPERWORK TO THE OKLAHOMA TAX COMMISSION ALONG WITH THE TRANSFER FEE.

TIMING AND FEES

IT'S IMPORTANT TO COMPLETE THE TITLE TRANSFER PROMPTLY, USUALLY WITHIN 30 DAYS OF THE SALE, TO AVOID PENALTIES. FEES VARY DEPENDING ON THE VEHICLE TYPE AND PROCESSING METHOD, BUT YOU CAN EXPECT TO PAY AROUND \$11 TO \$16 FOR THE TITLE TRANSFER ITSELF, PLUS ANY APPLICABLE TAXES.

TIPS FOR BUYERS AND SELLERS REGARDING OKLAHOMA VEHICLE TITLE HISTORY

- ****KEEP COPIES OF ALL DOCUMENTS:**** MAINTAIN RECORDS OF THE TITLE, BILL OF SALE, AND ANY LIEN RELEASES.
- ****USE LICENSED DEALERS WHEN POSSIBLE:**** DEALERS OFTEN HAVE MORE EXPERIENCE IN HANDLING TITLE TRANSFERS AND MAY OFFER WARRANTIES.

COMMON PITFALLS TO AVOID

- ****BUYING A VEHICLE WITH A STOLEN TITLE:**** THIS CAN HAPPEN IF THE TITLE HAS BEEN TAMPERED WITH OR FORGED.
- ****IGNORING ODOMETER FRAUD SIGNS:**** VERIFY ODOMETER READINGS AGAINST THE TITLE HISTORY AND VEHICLE CONDITION.

ANOTHER LIMITATION IS THAT TITLE HISTORY FOCUSES PRIMARILY ON OWNERSHIP AND LEGAL STATUS, RATHER THAN PROVIDING A COMPLETE MECHANICAL OR MAINTENANCE RECORD. THUS, TITLE HISTORY REPORTS SHOULD BE USED IN CONJUNCTION WITH VEHICLE INSPECTIONS AND SERVICE RECORDS FOR A HOLISTIC EVALUATION.

FURTHERMORE, OKLAHOMA'S INTEGRATION WITH THE NATIONAL MOTOR VEHICLE TITLE INFORMATION SYSTEM (NMVTIS) FACILITATES NATIONWIDE CHECKS, HELPING TO PREVENT TITLE FRAUD ACROSS STATE LINES.
