THIS POTENTIAL DRAWBACK UNDERSCORES THE IMPORTANCE OF INTEGRATING THESE TOOLS THOUGHTFULLY INTO AN OVERALL EDUCATIONAL STRATEGY.

POTENTIAL CHALLENGES AND LIMITATIONS

- **CONTENT SCOPE:** WHILE FOCUSED ON CHAPTER 7 TOPICS, COMPREHENSIVE ACCOUNTING MASTERY REQUIRES ENGAGEMENT WITH A BROADER RANGE OF CHAPTERS AND SUBJECTS.
