In what ways did the continuation of two-party competition after 1860 help the North win the Civil War? Most of the essays have been published previously over a twenty-year span, but there are also two new pieces. The Mysterious Disappearance of the American Whig party, originally delivered as the Commonwealth Fund Lecture at University College London in February, 1990, seeks to explain why the Whig party died in the 1850s. This essay contrasts the fate of the Whig party with the fates of the Republican party in the 1930s and 1970s and the British Conservative party in the 1840s and 1850s - parties that survived similar, indeed graver, challenges than those to which the Whigs succumbed. In addition, Holt has written an excellent introduction in which he explains how he came to write the essays and reflects upon them in light of the current state of political history as a discipline. *Political Parties and American Political Development from the Age of Jackson to the Age of Lincoln* offers provocative insights into both the history of nineteenth-century politics and the way it is studied.
